#### **Treeworks**

- (i) **NPA CONS/20/0460 Alice Lisle Inn, Gorley Road, Rockford, BH24 3NA**  
Fell 1 x Lime Tree, Fell 1 x Field Maple tree & Prune 1 x Alder tree

The work is necessary to prevent potential damage to an oil tank behind the public house. The trees are intermingled and not in the public view from the road.

- (ii) **NPA CONS/20/0456 Ibsley House, Mockbeggar Lane, Ibsley BH24 3PR**  
Reduce failed limbs by 2m to make a smaller crown on 1 x Oak Tree

The work required is to reduce the length of limbs of an Oak tree which has had some structural damage (probably due to wind). Cllr Errington noted that the application states that the tree is located between the house entrance and field entrance, but this is actually an Ash tree. The Oak tree is actually further down the road, the drawing is more than likely inaccurate. Cllr Blake suggested that we need to make sure that the applicant is referring to the damaged Oak tree, not the Ash tree as indicated on the drawing.

It was proposed by Cllr Errington to raise no objection. Chairman suggested that we respond with no objection but with additional comments and subject to a site visit. **ALL IN FAVOUR**
